## **POLICE PENSION INCREASE**

The September 2021 CPI (Consumer price Index) has been announced and stands at 3.1% and therefore, Police Pensions will rise by this amount in April 2022.

## **SECRETARY'S REPORT**

Winter is fast approaching, and it is hoped that with the success of Covid Vaccinations and the booster programme that is currently underway together with the Influenza vaccination programme that serious illness resulting in hospitalisation will be reduced and any further measures will not be required. Unfortunately, infection rates for Covid are still far too high and hospital admissions and deaths are increasing albeit at a far less level than previously encountered. However, with recent Government Ministers telling us rates could increase to 100,000 a day in Winter and logically deaths will also increase and once again it looks as if the Government are going to increase further measures when again it will be to late. It would therefore appear that this Government have learnt no lessons in the fight against this deadly

virus. The booster vaccination programme appears to have stalled somewhat and from being world leaders in this field we are fast becoming one of the worst in the Europe.

The Triple Lock on pensions has been withheld for a 12-month period and therefore with the increases in energy prices, petrol, and diesel together with increasing prices in shops many pensioners face a very tough Winter as do many low-income families. Fortunately, Police pensioners although not well off tend to suffer a lesser impact than most but they still will have a reduction in their standard of living. It is hoped that after the 12 months have elapsed the Government will as promised to, re-instate the Triple Lock but owing to previous U-turn's this remains to be seen. NARPO HQ have asked that NARPO take up this issue with Government and many Branches have expressed the view that in current economic situation and the fact that cost of Covid epidemic must be offset then Police pensioners may look somewhat selfish in view of their financial situations, and it would be far better to see if the Triple Lock is continued after the 12-month halt and then take up the issue should they decide not to re-instate. It should be borne in mind that the Triple Lock has long been talked about by Government with a view to ending it. If members can give some thought to this issue as it will be discussed at the Meeting.

Once again Christmas Gifts of £50 will be delivered to all Branch widows in December by the Secretary. Owing to no meeting be held in the Spring 2021 the Committee have all agreed that this payment continue this year.

I would also ask that if any member has difficulties due to Covid or any other issues that they contact the Secretary to see if anything can be done to alleviate any problems. We are after all a welfare organisation and are here to help and assist!

The Branch would like to invite any member attending this Meeting if they wish to arrive a 6pm and we will organise a meal at the Appleyard Restaurant. This can be either a curry or any other option on the menu. The Branch will pay £5 towards the cost of this meal and the member will pay the rest. Most meals are at a cost of £9.95 and it is hoped that more members will attend this Meeting. Any member wishing to attend must contact Secretary in advance so that arrangements can be made with the Appleyard Restaurant for numbers.

Finally, may I wish all members of the Branch and their families a Happy Christmas and hopefully a much better 2022, as it remains to be seen if Government can sort out issues with Covid, food and other supplies.

#### CHAIRMAN'S REPORT

Following a very long time with 'Lockdown' due to Covid 19 Restrictions, it has been a very difficult period with Meetings having to be cancelled, including our first Medway & District NARPO Meeting which was going to be held at our new venue, the Appleyard Club, in the Avenue of Remembrance, Sittingbourne, where there are better facilities, including off street parking and for the benefit of members with mobility difficulties everything is on ground floor level, including a bar and provision for food.

Hopefully we will have our Winter Meeting there on Tuesday 16th November 2021 commencing at 7.30pm and those wishing to come along earlier at 6.00pm hot food from the

restaurant will be laid on at appox. £10.00 per head with a £5.00p subsidy being paid by the Branch.

Although the Quarterly Kent Branch Meetings of NARPO had been cancelled at the Kent Police Training College Maidstone, there were two Meetings held via Zoom, which I attended, but there was not a lot to report, except the main things of interest to members were the new Kent Police Memorial Garden, which had been handed over by KCC Architect's to the Chief Constable. ## **NO 5 REGION ANNUAL GENERAL MEETING**

The next Meeting will be held at Police Federation Offices in Leatherhead, Surrey on Saturday 26<sup>th</sup> March 2022 when the Chairman and Secretary will attend. Hopefully if the

situation remains the same this will enable Branches to attend in person following recent Covid restrictions.

#### **WIDOWS PENSIONS/REGULATION C9 POLICE PENSIONS REGULATIONS 1987**

As you are aware, NARPO have been supporting the ongoing legal challenge to Regulation C9 of the Police Pensions Regulations 1987.

Regulation C9 prevents a Widow or Widower of a former serving Police Officer to claim their loved one's Police Pension after their death, where the Widow or Widower decides to cohabit or remarry. The view of NARPO and all its members has always been that Regulation C9 discriminates against those Widows or Widowers who find themselves in that situation. NARPO's view, based upon legal advice, is that Regulation C9 also breaches the fundamental Human Rights of the Widow or Widower and their families.

The legal challenge continues. There was a Hearing in May 2021. Since that Hearing those individuals who are raising this issue with the Court were ordered to provide certain documents to the Court setting out the claims that they bring. The Secretary of State responded to those documents. On 20<sup>th</sup> August 2021, the documents were considered by the Court and a decision of the Court was handed down by His Honour Judge Sephton QC, sitting as a Judge of the High Court in Manchester.

HHJ Sephton QC determined that the claims brought by the three individuals who now challenge the legality of Regulation C9 can and should be allowed to proceed to a full and final Hearing. That Hearing will now take place in Manchester on 5<sup>th</sup> and 6<sup>th</sup> April 2022. As well as our Solicitors and Counsel who represent the individuals bringing the challenge, the Commissioner of Police of the Metropolis and the Secretary of State for the Home Department will also be represented at Court, through their Lawyers.

Significantly the Court allowed the claims of both the Widows and Widowers who feel unable to remarry or cohabit because of the financial implications of Regulation C9 and those Widows and Widowers who have remarried or cohabited, who now endure continuing financial losses because of Regulation C9, to have their claims determined by the Court. What that means is that if the claims are successful and the Court does determine that Regulation C9 should no longer stand, then all individuals who are affected daily by the operation of this unjust Regulation will be affected by this legal ruling.

Currently our Legal Team are preparing for the final Hearing. There is a lot of work for the Legal Team to do now, to prepare for the Hearing. NARPO and the Police Federation are and will continue to work closely with the Legal Team and the individuals bringing this claim, to make sure that the claim is fully prepared and that all issues that need to be put to the Court at the final Hearing, are put before the Court in the best possible way.

We will of course update you closer to the time about any developments in the claim and the arrangements for the final Hearing. At this stage, however, we can at least now be confident that, for the first time, there will be a full Judicial determination about the legality of Regulation C9. We and all our members together with all serving Police Officers say that Regulation C9 is and always was, discriminatory, unfair and in breach of families' fundamental Human Rights. Those claims will now be determined by the High Court in April 2022.
